Dear Ms. Dortch:

BellSouth Long Distance, Inc. ("BellSouth Long Distance"), by counsel, hereby withdraws IBFS File No. SCL-LIC-20060414-00005, which was filed on April 12, 2006 ("Application"). BellSouth Long Distance filed the Application seeking *nunc pro tunc* approval of an assignment of certain submarine cable licenses ("Licenses") from BellSouth International, Inc. (now BellSouth International, LLC) ("BellSouth International") to BellSouth Long Distance. On April 19, 2006, at the request of the International Bureau, BellSouth Long Distance filed another application, IBFS File No. SCL-ASG-20060419-00006, requesting approval of the assignment of these licenses from BellSouth International to BellSouth Long Distance, but not requesting *nunc pro tunc* treatment. On June 7, 2006, the Bureau approved the subject assignment.¹

At the time of the April 19 filing, BellSouth Long Distance understood that the April 19 filing was intended to amend and supersede the initial Application. However, in order to avoid any confusion regarding the current disposition of these licenses, BellSouth Long Distance hereby withdraws the initial Application, IBFS File No. SCL-LIC-20060414-00005.
