On behalf of the owners of the Southeast Asia-US ("SEA-US") submarine cable system, I hereby respond to a request from International Bureau staff seeking confirmation in the above-referenced file that Telekomunikasi Indonesia International (USA) Inc.'s proposed acquisition of TeleGuam Holdings, LLC d/b/a GTA (the "GTA Acquisition") was never consummated. The parties to that transaction notified the Commission in the attached letter dated June 2, 2016, and filed in WC Docket No. 15-148 that the GTA Transaction would not be consummated that that they were withdrawing their applications for consent to that Transaction. Consequently, the ownership information provided on pages 3 through 6 of Exhibit I to the cable landing license application filed on June 26, 2015, in the above-referenced file remains current and correct.

Dear Ms. Dortch:

TeleGuam Holdings, LLC ("TeleGuam"), AP TeleGuam Holdings, Inc. ("AP TG"), and Telekomunikasi Indonesia International (USA) Inc. ("Telkom USA") (collectively, "Applicants") filed a series of applications pursuant to sections 214 and 310(d) of the Communications Act of 1934, as amended ("Act"), requesting approval to transfer of control of TeleGuam from AP TG to Telkom USA, and filed a petition to permit TeleGuam to exceed the 25 percent benchmark for foreign ownership in section 310(b)(4) of the Act. The Commission established a combined pleading cycle via a Public Notice released on June 25, 2015 (DA 15-758).

Applicants hereby advise the Commission that the proposed transaction will not be consummated. As a result, Applicants respectfully withdraw the pending applications and petition.

This letter is being filed in the Commission's Electronic Comment Filing System ("ECFS") and International Bureau Filing System ("IBFS"). In addition, a withdrawal request for
