> Re: Pacific Carriage Limited Inc. and Southern Cross Cables Limited, Application for a License to Land and Operate a Private Fiber-Optic Submarine Cable System Connecting Australia, New Zealand, Fiji, Samoa, Tokelau, Kiribati, and California, the Southern Cross NEXT System

Dear Ms. Dortch:

Through their counsel, Pacific Carriage Limited Inc. and Southern Cross Cables Limited (collectively, "Applicants") supplement the above-referenced application to land and operate the Southern Cross NEXT system<sup>1</sup> to include updated ownership information.

Specifically, Applicants update part H of the application to add MFS Globenet, Inc. as an indirect holder of a 12.3-percent voting and economic interest in each of PCLI and SCCL, and to identify corresponding reductions in the interests held by each of TCNZ (Bermuda), Optus Networks Pty Limited ("Optus"), and SingTel EInvestments Pte Ltd ("SingTel EInvestments"). The interests held by Telstra Holdings Pty Limited remain unchanged.

For clarity, Applicants restate the direct and indirect ownership interests in each of PCLI and SCCL as follows:




