Re: Response Required – Potential Dismissal of Application for Submarine Cable Landing License filed by Edge Cable Holdings USA, LLC, China Mobile International Limited, and Amazon Data Services, Inc., File No. SCL-LIC-20200910-00044

Dear Mr. Guhr:

On September 10, 2020, Edge Cable Holdings USA, LLC, China Mobile International Limited, and Amazon Data Services, Inc. (collectively, the Applicants) filed the above referenced application with the Federal Communications Commission (Commission) for the construction of the CAP-1 Cable System (Application). On September 30, 2020, the International Bureau referred the Application to the Department of Justice (DOJ), the Department of Defense, and the Department of Homeland Security for their views on any national security, law enforcement, foreign policy or trade policy concerns related to the foreign ownership in the CAP-1 Cable System.¹

On October 6, 2020, the Chair of the Committee for the Assessment of Foreign Participation in the United States Telecommunications Services Sector (Committee) requested that the Commission defer action on the Application while the Committee reviews the Application for any national security and law enforcement concerns that may be raised by foreign participation in the U.S. telecommunications services sector.² Pursuant to Executive Order 13913,³ the Chair will notify the Commission when the Chair has determined that the 120-day initial review period has begun.⁴

On December 15, 2020, the Committee recommended that the Application be dismissed without prejudice because the Applicants have missed three deadlines to provide complete responses to the Committee's triage questions.⁵ The Applicants are now required to respond to the Committee's questions no later than **Friday**, **January 15, 2021**.

Please inform us no later than **January 15, 2021** if you want to continue to seek the requested submarine cable landing license and indicate in the filing the date when you provided the requested information to the Committee. If you fail to either respond to this letter or to provide responses to the Committee's questions by **January 15, 2021**, we provide notice that the above referenced Application will be dismissed without prejudice under section 1.748(a) of the Commission's rules.⁶

Dear Ms. Dortch:

The Commission is notified that the Committee for the Assessment of Foreign Participation in the United States Telecommunications Services Sector ("Committee") recommends that the above-referenced application ("CAP-1 Application") be dismissed without prejudice.¹

The applicants for the CAP-1 Application have missed three deadlines to provide complete responses to the Committee's triage questions. The Committee initially requested complete responses by November 11, 2020. This deadline was extended, at applicants' request, to December 3, 2020. On December 3, applicants requested a second extension to December 11.² Counsel for applicants stated that applicants would submit a partial response on December 4, but that one missing exhibit still needed to be translated.³ As of today, the applicants' triage responses remain incomplete, and the Committee is unable to complete its review. Accordingly, the Committee recommends that the CAP-1 Application be dismissed without prejudice.
