Dear Ms. Coca:

On behalf of the CAP-1 applicants, Edge Cable Holdings USA, LLC (“Edge USA”) responds to your request¹ to follow up with the Committee for the Assessment of Foreign Participation in the United States Telecommunications Services Sector (“Team Telecom”) to confirm whether or not the Applicants continue to seek a cable landing license for the CAP-1 system and to address any outstanding information requests in light of the letter from the U.S. Department of Justice, as Chair of Team Telecom, requesting that the Commission dismiss the above-referenced application due to alleged incomplete responses to Team Telecom information requests.²

Edge USA confirms the Applicants continue to seek a cable landing license for the CAP-1 system. Edge USA further confirms that as of December 15, 2020, (the date of the DOJ Letter) the CAP-1 applicants have addressed all outstanding questionnaires and information requests issued by Team Telecom, including the translated confidential exhibit referenced in the DOJ Letter. The Applicants are not aware of any other pending information requests from Team Telecom and have requested that DOJ, as Chair of Team Telecom, confirm that understanding.
