Re: *Landing Point Notification for the St. Lucia Landing of the Antilles Crossing System, FCC File No. SCL-LIC-20031125-00032*

Dear Ms. Dortch:

Pursuant to Sections 1.767(a)(5) and (g)(8) of the Commission's rules, Antilles Crossing-St. Croix, Inc. ("ACSC," FRN 0013963624), hereby notifies the Commission of details of the St. Lucia landing of the Antilles Crossing system.<sup>1</sup>

The Antilles Crossing system will land in St. Lucia as follows:

- Beach landing: Vigie Bay, St. Lucia, 14° 01.6030N Latitude, 60° 58.8650W Longitude; and
- Cable station: Antilles Crossing St. Lucia Teleport, Vide Bouteille (no street address), St. Lucia, 14° 01.590N Latitude and 60° 58.825W Longitude.

ACSC's predecessor in interest had previously notified the Commission of the St. Croix and Barbados landing points in the original license application, along with a map of the landings, including the St. Lucia landing.<sup>2</sup>
