Dear Ms. Dortch:

On December 2, 2019, AT&T Mobility Puerto Rico Inc. (“AMPR”) filed an application seeking Commission approval to modify the submarine cable landing license for the Americas-II cable system¹ to relinquish its interest in this license pursuant to Section 1.767(m)(2) of the Commission’s rules.² The application was given File No. SCL-MOD-20191202-00038.

Section 1.767(m)(2) requires the party seeking to relinquish its interest to serve the modification application on each other licensee of the cable system. To identify the licensees to be served, AMPR used the list of Americas-II licensees the Commission released in connection with FY 2016 regulatory fees.³ As reflected in the Certificate of Service for the modification application, AMPR served those entities through the contact people listed for their FCC Registration Numbers in the Commission’s CORES database, except that IMPSAT USA, Inc. was served through the offices of CenturyLink, its current corporate parent.⁴

International Bureau staff subsequently informed me that their records indicate that seven additional entities still might be co-licensees of Americas-II and asked that AT&T research their status. AT&T found the following information from Americas-II consortium records, corporate records in the seven entities' jurisdictions of formation, and other sources:

- *IDB Worldcom Services, Inc.* – Between May and June 2007, consortium records indicate that IDB's interests were combined with those of MCI International, Inc.'s. Pat Merrick of Verizon, whom AMPR served originally for MCI International, Inc., advises that IDB was merged into MCI Communications Corporation. Mr. Merrick says he can accept service for MCI Communications Corporation too.
- *IDT Corporation* – Between June and December 2008, consortium records indicate that IDT defaulted on its payments to the consortium, which reclaimed IDT's capacity. Consortium member Compañía Dominicana de Teléfonos, C. por A. ("CODETEL"), which is now a part of América Móvil (d/b/a Claro), acquired IDT's capacity by paying IDT's debt to the consortium.
- *LC Communications* – According to the order granting the submarine cable landing license, LC was a trade name for International Telecom, Inc.⁵ Between October 1999 and April 2000, consortium records indicate that LC transferred its capacity to consortium member Centennial (which subsequently was acquired by AT&T). As explained in the relinquishment filing, Centennial's interests in Americas-II were assigned to AT&T Mobility Puerto Rico Inc., which has conveyed its rights and obligations under the Americas-II cable System Construction and Maintenance Agreement to consortium member AT&T Corp. Consortium records also indicate that LC officially exited the consortium between December 2008 and January 2009. The Delaware Secretary of State already had voided International Telecom, Inc.'s corporate status on March 1, 2008.⁶
- *Pacific Gateway Exchange (Bermuda) Limited* – Between July and November 2000, consortium records indicate that Pacific Gateway's capacity was reallocated

to various other consortium members: AT&T; Telecomunicaciones Ultramarinas de Puerto Rico (“ULTRACOM”), which is now part of PREPA Networks, LLC; multiple Cable & Wireless entities; Guyana Telephone and Telegraph Company (now Atlantic Teleconnection); and Embratel, which is now part of América Móvil (d/b/a Claro). The consortium records AT&T has reviewed do not indicate whether Pacific Gateway defaulted on payments to the consortium or simply returned its capacity to the consortium. Consortium records also indicate that Pacific Gateway officially exited the consortium between July 2003 and October 2004. Pacific Gateway already had been struck off the Bermuda Companies Register on September 23, 2002.⁷

- *STAR Telecommunications, Inc.* – Between August 2002 and January 2003, consortium records indicate that STAR’s capacity was transferred to a Cable & Wireless entity that belonged to the consortium. Consortium records also indicate that STAR officially exited the consortium between July 2002 and July 2003. Delaware Secretary of State records show that STAR forfeited its corporate status on December 31, 2006.⁸
- *Telia Carrier United States Inc.* – Consortium records indicate that Telia transferred its ownership interest to France Telecom, now Orange, in December 2003 and officially exited the consortium between November 2005 and November 2006.
- *WorldXchange Communications, Inc.* – Consortium records indicate that the consortium reclaimed WorldXchange’s capacity between July and October 2003 due to WorldXchange’s default on payments to the consortium; the capacity has not been distributed to another member. Consortium records also indicate that WorldXchange officially exited the consortium between July 2003 and October 2004. WorldXchange’s corporate status was voided by the Delaware Secretary of State on March 1, 2017.⁹

As requested by the staff, AMPR is filing this letter in IBFS as a supplement to its modification application. The attached certificate of service provides proof that this supplement is being served on each of the parties on whom AMPR served the modification application on December 2, 2019 and that the modification and this


