APPLICATION FOR SPECIAL TEMPORARY AUTHORITY International Bureau

On behalf of the licensees of the Columbus-2 submarine cable system,¹ SCL-LIC-19921110-00004, AT&T Corp. ("AT&T"), pursuant to 47 U.S.C. §§ 34-39, Executive Order 10,530, and 47 C.F.R. § 1.767, hereby requests that the Commission grant Special Temporary Authority ("STA") to allow the continued operation of the Columbus-2 cable following the expiration of the existing cable landing license on October 1, 2019, while the Commission considers the application for a new cable landing license for this cable filed on March 27, 2019.²

AT&T acknowledges, on behalf of the licensees, that the grant of this STA will not prejudice any action the Commission may take on the application for a new cable landing license, and that this STA can be modified or revoked by the Commission upon its own motion without a hearing. AT&T also acknowledges on behalf of the licenses that such continued operation of the cable would remain subject to the conditions set forth in the cable landing license released on July 13, 1993.

The application is currently under review by the "Team Telecom" Executive Branch agencies. As noted in the application, only the domestic segment of Columbus-2 linking the U.S. Mainland and St. Thomas in the Virgin Islands are now in operation. The application and this request for the grant of Special Temporary Authority request the continued operation of this domestic segment.

AT&T submits that the continued operation of the Columbus-2 cable is overwhelmingly in the public interest in helping to meet the demand for voice, data and internet services on routes between the U.S. mainland and the U.S. Virgin Islands, and connecting to other cables extending to various Caribbean islands, and Central and South America, and that it would not serve the public interest to cease operation of this cable, even on a temporary basis. The cable has been operated successfully for 25 years, has a current design capacity of 800 Gbps per second, and the United States terminal points currently operate at up to 600 Gbps.

Maintaining reliable communications facilities serving the U.S. Virgin Islands is particularly important following the “massive damage” to these islands caused by Hurricane Maria.³ As the U.S. Virgin Islands continues to work to overcome these major challenges, it is even more critical to avoid any diminution in the communications facilities that link consumers in this territory with the rest of the world. AT&T therefore requests the grant of this request.


