# Re: Applications filed by Global Crossing Limited and Level 3 Communications, Inc. for Consent to Transfer Control, IB Docket No. 11-78

Dear Ms. Dortch:

Level 3 Communications, Inc. ("Level 3"), by its attorneys, hereby notifies the Commission that the transfers of control and assignments of international section 214 authorizations, cable landing licenses, and satellite earth station authorizations from Global Crossing Limited ("GCL") and its subsidiaries contemplated in the above-referenced transaction were consummated on October 4, 2011. A copy of the press release announcing the consummation is attached hereto.

On September 29, 2011, the Commission issued a Memorandum Opinion and Order and Declaratory Ruling granting the applications filed in the above-referenced proceeding to, *inter alia*, transfer control or assign certain international section 214 authorizations, cable landing licenses, and earth station authorizations from GCL and its subsidiaries to Level 3.
