## PETITION TO ADOPT CONDITIONS TO AUTHORIZATIONS AND LICENSES

The Department of Homeland Security ("DHS") submits this Petition to Adopt

Conditions to Authorizations and Licenses ("Petition"), pursuant to Section 1.41 of the Federal

Communications Commission ("Commission") rules. Through this Petition, DHS advises the

Commission that the Agencies have no objection to the Commission approving the authority

sought in the above-referenced proceedings, provided that the Commission conditions its

approval on the commitment of Verizon Business Global LLC ("Verizon Business"), CWC New

Cayman Limited ("CWC New Cayman"), Columbus Networks USA, Inc. ("CNUSA", and

together with CWC New Cayman referred to as "C&W"), and Liberty Global plc ("Liberty

Global") to abide by the undertakings set forth in the March 7, 2017, National Security

Agreement ("2017 NSA"), which is attached hereto as Attachment A. The above-referenced

proceedings involve an application seeking Commission approval to transfer C&W's interest in

the cable landing license associated with the Gemini Bermuda Cable System, a fiber optic

submarine cable system connecting the United States and Bermuda (FCC File No. SCL-LIC
20070925-00017), to Liberty Global.

The Commission has long recognized that law enforcement, national security, and public safety concerns are part of its public interest analysis, and has accorded deference to the views of other U.S. government agencies with expertise in those areas. *See In the Matter of Comsat Corporation d/b/a Comsat Mobile Communications, etc.*, 16 FCC Rcd. 21,661, 21707 ¶ 94 (2001).

After discussions with representatives of Verizon Business, C&W, and Liberty Global in connection with the above-referenced proceedings, DHS has concluded that the commitments set forth in the 2017 NSA will help ensure that those agencies with responsibility for enforcing the law, protecting the national security, and preserving public safety can proceed appropriately to satisfy those responsibilities. DHS has also concluded, in consultation with Verizon Business, that the March 3, 2008 (subsequently amended on February 11, 2009) National Security Agreement between DHS and Verizon Business, which has been applicable to the Gemini Bermuda Cable System is no longer needed, has been terminated by mutual agreement of the parties, and can be removed by the Commission as a condition to the Gemini Bermuda cable landing license.

Accordingly, DHS, advises the Commission that it has no objection to the Commission granting the application referenced above, provided that the Commission conditions its consent on compliance by Verizon Business, C&W, and Liberty Global with the 2017 NSA.
