Notification of *Pro Forma* Transfer of Control

Dear Ms. Dortch:

In accordance with 47 C.F.R. § 1.767(g)(7), PC Landing Corp., the cable landing licensee of the Pacific Crossing cable system ("PC-1"), hereby notifies the Commission of its *pro forma* transfer of control pursuant to an internal reorganization.<sup>1</sup>

Pursuant to the internal reorganization, on July 1, 2019, all of the issued and outstanding shares of NTT America, Inc., the immediate parent of PC Landing Corp.,<sup>2</sup> were transferred from NTT Communications Corporation ("NTT Communications") to NTT Ltd. As reflected in the attached organizational charts showing PC Landing Corp.'s ownership structure prior to and following the *pro forma* transfer of control, both NTT Communications and NTT Ltd. are wholly-owned subsidiaries of Nippon Telegraph and Telephone Corporation ("NTT"), which remains the ultimate parent of PC Landing Corp.<sup>3</sup>

This will certify that the referenced transfer of control was *pro forma*, and together with all previous *pro forma* transactions, does not result in a change of PC Landing Corp.'s ultimate control.


