Cincinnati Bell Inc. and Red Fiber Parent, LLC, at the request of International Bureau staff, respectfully supplement the above-referenced applications (the "Red Fiber Parent Applications") to notify the Commission that Cincinnati Bell's indirect subsidiary Hawaiian Telcom Inc. ("HTI") on January 22, 2021 filed a separate application with the Commission seeking consent to assign the cable landing license for the Paniolo Cable System from Paniolo Cable Company, LLC ("Paniolo Cable Company") to HTI (the "Paniolo Assignment Application").¹ The Paniolo Assignment Application has been docketed as SCL-ASG-20210122-00006. The Cincinnati Bell/Red Fiber Parent Transaction is not contingent upon HTI's acquisition of the Paniolo Cable System, and thus, the Paniolo Assignment Application should be considered separate and apart from the Cincinnati Bell/Red Fiber Parent Transaction that is currently past Day 60 of the review by the Committee for the Assessment of Foreign Participation in the United States Telecommunications Services Sector.²
