**NOTICE OF WITHDRAWAL OF
APPLICATION FOR CONSENT TO TRANSFER CONTROL OF
CABLE LANDING LICENSE AUTHORIZATION**

On October 15, 2020, Telia Company AB (“Telia Company”), Telia Carrier U.S. Inc. (“Telia Carrier”) and Oura BidCo US, Inc. (“Oura BidCo US”) (collectively, “Applicants”) filed an application seeking the Federal Communications Commission (“the Commission”)’s consent to transfer control of Telia Carrier’s interest in the TAT-14 submarine cable to Oura BidCo US.¹ Pursuant to 47 C.F.R. § 1.748, the Applicants notify the Commission of the withdrawal of that application and request that it be dismissed without prejudice, because the TAT-14 submarine cable was retired from service on December 15, 2020 and has been powered down.² As a result, the cable is no longer operational.

This notice of withdrawal in no way affects the Applicants' joint application seeking consent to transfer control of Telia Carrier's domestic and international Section 214 authorizations to Oura BidCo US.³ The parties look forward to working with the Commission to secure the necessary approvals to transfer control of those authorizations.
