Re: Pro Forma Transfer of Control of Cable Landing Licenses for the AEC-1 Submarine Cable System (File Nos. SCL-LIC-20140206-00002 and SCL-MOD-20210105-00001), Havfrue Submarine Cable System (File Nos. SCL-LIC-20180511-00010 and SCL-ASG-20201130-00047), and Amitié Submarine Cable System (File No. SCL-LIC-20200807-00036)

Dear Ms. Dortch:

Pursuant to 47 U.S.C. § 34, Executive Order No. 10,530, and 47 C.F.R. §§ 1.767(a)(11) and (g)(7),¹ Aqua Comms (Americas) Inc. ("Aqua Comms Americas") (FRN 0027231851) and America Europe Connect 2 USA Inc. ("AEC2 USA", together with Aqua Comms Americas, the "Aqua Comms Licensees") (FRN 0027231851) provide a notification regarding the *pro forma* transfer of control of their respective cable landing license interests for the AEC-1, Havfrue, and Amitié submarine cable systems.

1. Background

The *pro forma* transfer of control of the Aqua Comms Licensees' cable landing license interests for the AEC-1, Havfrue, and Amitié submarine cable systems results from the insertion of an intermediate holding company through which The 2013 Bake Family Trust holds its interest in the Aqua Comms Licensees. This entity, Aqua Ventures Hold Co Limited ("Transferee"), acquired The 2013 Bake Family Trust's interest in AVL effective March 27, 2020.² As noted in the supplemental notification submitted on April 21, 2021 with respect to a separate *pro forma* transaction, the Aqua Comms Licensees were not previously aware of this change in structure, which resulted in a *pro forma* transfer of control, and regret the belated

notification of this *pro forma* change. The Aqua Comms Licensees have reminded their upstream owners of the importance of timely notifying all such *pro forma* transactions.

By its signature below, Transferee certifies to the following: (1) Transferee is not a foreign carrier in any destination market where any of the AEC-1 or Havfrue, or Amitié submarine cable systems land; (2) Transferee will not control a foreign carrier in any destination market where any of the AEC-1, Havfrue, or Amitié submarine cable systems land; (3) no entity that will own more than 25 percent of Transferee, or that controls Transferee, controls a foreign carrier in any destination market where any of the AEC-1, Havfrue, or Amitié submarine cable systems land; and (4) no grouping of two or more foreign carriers (or parties that control foreign carriers) own, in the aggregate, more than 25 percent of Transferee and are parties to, or beneficiaries of, a contractual relation affecting the provision or marketing of arrangements for the terms of acquisition, sale, lease, transfer, and use of capacity on any of the AEC-1, Havfrue, or Amitié submarine cable systems.
