(formerly Telenor Satellite, Inc. and Vizada Satellite, Inc.) hereby seeks authorization to use NSS-9 at 177.0 degrees W.L. as a Point of Communication for the remote Earth Station on Vessels (ESV) antennas for which its referenced application requested authorization for operation to provide C−Band ESV service through the Santa Paula teleport, call sign KA249. As before, the service will be provided via a hub antenna that already has been licensed by the Commission and has ALSAT authority to communicate with NSS-9. See File No. SES−MOD−20061207−02107, granted Jan. 17, 2007 and SAT-PPL-20080811-00152 (adding NSS-9 to Permitted Space Station List), granted February 13, 2009. Attached are coverage maps for NSS-9 to show, as required by Section 25.221(a) (11), the geographic area(s) in which the ESVs will operate via NSS-9.
