Consistent with discussions with FCC Staff on September 19, 2013, no Form 312, Schedule B is submitted with this amendment because the only changes requested herein are the removal of IS-27 as a point of communication and the addition of T14R and Satmex 8. Both of these satellites will operate within the scope of the technical parameters, including the orbital arc range, that are specified in the pending modification application.
