
Dear Ms. Dortch:

On behalf of Transvision International Teleport, L.P. ("Transvision"), applicant for a license for a new earth station with call sign E030087, we hereby respectfully request that Transvision's amendment filed June 24, 2003 (File No. SES-AMD-20030624-00889) be withdrawn. The subject amendment sought Commission consent to delete the extended band frequencies applied for in Transvision's underlying license application (File No. SES-LIC-20030418-00503). Transvision has determined that it still needs the extended band frequencies specified in its license application. Accordingly, Transvision is simultaneously filing an electronic amendment to its license application to provide the requisite EMC analysis.
