Intelsat LLC files this amendment to remove the Permitted List and insert IA-8 at 89 degrees W.L. and IA-8 at 109.2 degrees W.L. as the points of communication. This amendment also corrects one of the emission designators to be 100KG7W (not 1000KG7W) and specifies that the maximum EIRP density for the 29500 to 30000 MHz band should be 20.89.
