This amendment provides the RF radiation hazard analysis. In addition, it provides the input power at the antenna flange - 75.0 watts and the maximum EIRP density toward the horizon (dBW/4kHz) - 49.0 dBW. and the maximum EIRP per carrier - 75.0.
