This minor amendment is to submit a revised orbital debris mitigation statement in accordance with the Public Notice of October 13, 2005 (See DA 05-2698) and to submit updated ownership information for Inmarsat. The revised orbital debris mitigation statement is included in the attached revised Technical Annex(Section A.21). In addition, subsequent to the filing date of the original application, sales of Inmarsat stock have resulted in the company having no shareholders with a greater than 10 percent interest. Previously two private equity funds held interests of greater than 10 percent in Inmarsat and were disclosed in the answer to Question 42(a) in the original application. A revised response to Question 42(a), incorporating the new ownership information, is attached. No other changes are requested in this minor amendment.
