Minor amendment to pending application for blanket authority to operate up to 40,000 Mobile Earth Terminals in conjunction with Inmarsat's Broadband Global Area Network (BGAN) service satellites. The amendment reflects a pro forma internal reorganization involving original applicant MVS USA, Inc. (MVS USA) and affiliate and new applicant MVS Fed, LLC. The Commission has previously deemed transactions such as these as pro forma, and amendments reflecting such transactions as this as minor in nature. The remaining technical changes are minor technical clarifications Commission staff have requested of BGAN applicants in the period since MVS USA filed the original application and the changes do not reflect changes to the technical parameters or operations of the service.
