This filing supplements the record in this proceeding with additional coordination letters reaffirming the agreement of the satellite licensees within six degrees of the satellites to be used by Row 44 that the proposed remote terminals will operate in compliance with the FCC's two-degree spacing requirements. The coordination letters also provide responses to prior FCC staff questions regarding operation of the remote terminals. No technical changes are proposed in this filing; therefore no Schedule B is provided.
