Dear Ms. Dortch:


Following up on Row 44, Inc.'s June 16, 2009 meeting with members of the FCC's Satellite Division staff, I am transmitting herewith on behalf of Row 44 a statement signed by each of the three satellite operators, EchoStar Corporation, Intelsat, and SES Americom, Inc., (collectively "Satellite Operators"), that are parties to coordination letters with Row 44 dated June 5, 2008, June 6, 2008 and January 6, 2009, and the February 6, 2009 letter agreement concerning test flighting of the Row 44 aeronautical mobile-satellite service ("AMSS") system. *See Row 44, Inc.*, STA Order and Authorization, DA 09-585, slip op. at 2 (¶ 4) & n.4 (Sat. Div., rel. March 13, 2009) (referencing the February 6, 2009 letter agreement). The three Satellite Operators are the sole parties that have licensed Ku-band space segment capacity within six degrees of the three satellites via which Row 44 proposes to provide AMSS pursuant to the above-referenced blanket license application. The attached statement, signed in counterparts, reflects that each of the Satellite Operators has no objection to grant of an FCC blanket earth station license to Row 44, as requested in the above-referenced application.
