

**Response to Question A20**  
**Amended Ownership and Control of the Licensee**

In response to Item A20 of Form 312, Schedule A, the Applicant details the proposed ownership and control of licensee ITC Global USA, LLC (“ITC Global USA”) in connection with the proposed transfer of control. This Exhibit E updates the information previously filed with the Commission on January 15, 2021, in order to reflect changes in indirect ownership of the Applicant. It does not change the identity of the transferee. Upon consummation of the Proposed Transaction, ITC Global USA will have the following 10-percent-or-greater interest holders:

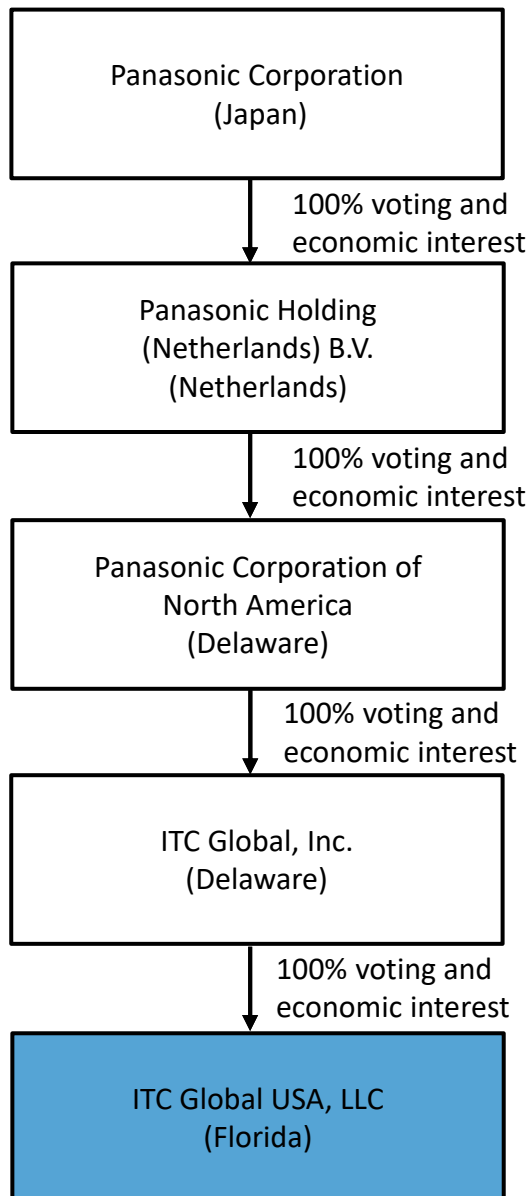

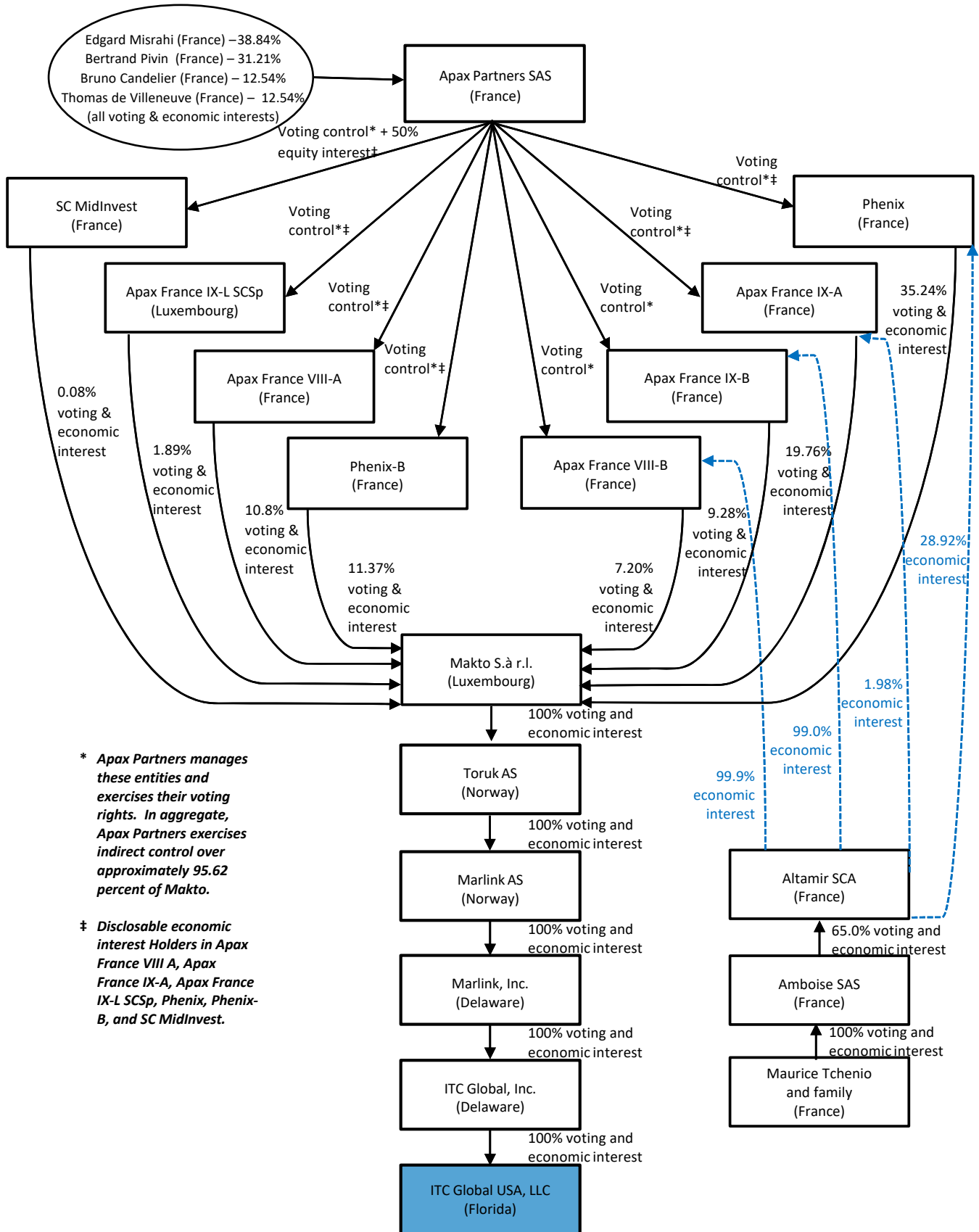
