This facility is used for receiving broadcast network programming and related data. Since this is an existing installation, it was originally filed as a limited exception to the application freeze per DA18-398. This application was also filed without coordination per the waiver granted in DA18-398. Coordinates provided in Schedule B are based on the WGS84 datum.
