## Re: Minor Amendment – Application for New Earth Station Authorization (FCC File Nos. SES-LIC-20200427-00449 and SES-AMD-20201030-01203); GUSA Licensee LLC – Clifton, TX

Dear Mr. Sullivan:

GUSA Licensee LLC (together with its parent Globalstar, Inc., "Globalstar"), pursuant to Section 25.116 of the Commission's rules,<sup>1</sup> hereby amends its pending application for permanent authority for the operation of an additional feeder link earth station antenna in Clifton, Texas, under call sign E201992, primarily for testing purposes.<sup>2</sup> In this minor amendment of the April Application, Globalstar requests permanent authority for two additional receive emission designators associated with a new burst mode packet data carrier that will support shortmessaging data services. Specifically, Globalstar now adds receive emission designators 230KG7D and 280KG7D to the list of emission designators provided in response to Schedule B, Question E50 of FCC Form 312.<sup>3</sup> The addition of these receive emission designators will permit flexible implementation of this new carrier.
