VAAI, the parent of proposed assignee GUSA LLC, has two foreign directors, Christopher Gent and Ken Hydon, both of the United Kingdom. Section 310(b) of the Communications Act of 1934, as amended, 47 U.S.C. § 310(b), permits foreign citizens to be directors of companies like VAAI that directly or indirectly control a U.S. corporation holding common carrier radio licenses. The Wireless Telecommunications Bureau previously determined that “[b]ecause the United Kingdom is a member of the World Trade Organization (WTO), under the Commission’s *Foreign Participation Order*, we presume that the public interest would be served by authorizing, under Section 310(b)(4), common carrier radio licenses held by entities indirectly owned by Vodafone [Group Plc.] and citizens of the United Kingdom.” *AirTouch Communications, Inc. and Vodafone Group Plc.*, 14 FCC Rcd 9430, 9434 (1999) (footnote omitted). Vodafone Group Plc. will continue to hold its indirect ownership of earth station licensees through U.S.-incorporated subsidiaries Vodafone US Partners and VAAI.
