Rite Aid Corporation ('Rite Aid') is the licensee of a VSAT system including a Hub Station (E920495), and two (2) remote VSAT network Stations (E920496 and E920497). Utilization of these facilities enables Rite Aid to communicate with its approximately 3,400 retail pharmacies in 28 states and the District of Columbia, where several million prescriptions are filled each week. The system enables rapid processing of credit card authorizations, third-party prescription claims, inventory fulfillment and pricing data. For internal purposes related to corporate restructuring, it is proposed to assign the VSAT licenses from Rite Aid Corporation, to Rite Aid Headquarters Corporation, its wholly-owned subsidiary.
