On July 16, 1996, the FCC granted an application to assignWSTR-TV from Cincinnati TV 64 Limited Partnership toWSTR Licensee, Inc. See FCC File No. BALCT-19960205IB. The assignment was consummated July 31, 1996. Thus, a similar assignment of WV20 will permit continued joint operation of the earth station and television facilities by the same licensee in the provision of television broadcast services.
