On April 29, 2004, Verestar, Inc. (Debtor-in-Possession), Verestar Networks, Inc. (Debtor-in-Possession) (collectively, "Verestar") and SES AMERICOM, Inc. ("SES Americom") filed a series of applications seeking Commission consent to the assignment of certain licenses and authorizations from Verestar to SES Americom. *See* File Nos. SES-ASG-20040503-00672, SES-ASG-20040503-00673, ITC-ASG-20040429-00186, ITC-ASG-20040429-00187; ULS Submission No. 0001685559; and the Domestic Section 214 Authorization assignment application filed by hand with your office on that date. These applications appeared on *Public Notice* as acceptable for filing on May 26, 2004. *See Public Notice*, DA 04-1502.<sup>1</sup>

The application in File No. 0001685559 covers, *inter alia*, certain common carrier microwave licenses. Verestar and SES Americom hereby withdraw those common carrier microwave licenses (specified in Attachment A hereto) from that application; the relevant ULS submission will be modified accordingly. The requests for consent to the


