Dear Ms. Dortch:

Radio License Holding I, LLC ("Radio License") hereby requests an additional sixty-day extension of time to consummate the assignment ("Assignment") set forth in IBFS File No. SES-ASG-20060301-00335 ("Application"). As stated in the Application, the Assignment involves a two-step transaction—a *pro forma* assignment ("Step One") followed by a substantial transfer of control ("Step Two") in connection with a proposed merger of certain broadcast radio subsidiaries of The Walt Disney Company ("TWDC") and Citadel Broadcasting Corporation ("Merger Transaction").

The Federal Communications Commission ("FCC") consented to the Assignment on April 18, 2006. The FCC granted an extension, until December 14, 2006, to consummate the Assignment because other applications ("Other Applications") related to the Merger Transactions were pending before the FCC, *see, e.g.*, BTC-20060228ABG.

On October 18, 2006, ABC Detroit, Radio License's predecessor, notified the FCC that Step One of the Assignment was completed on September 28, 2006 and that Radio License is now the licensee of E861076.<sup>1</sup> Because the Other Applications still remain pending, an extension of time to consummate the Step Two of the Assignment is necessary. Accordingly,
