Request for Extension of Time to Consummate

Dear Ms. Dortch:

Radio License Holding I, LLC ("Radio License") hereby requests an additional sixty-day extension of time to consummate the assignment ("Assignment") set forth in IBFS File No. SES-ASG-20060301-00335 ("Application"). As stated in the Application, the Assignment involves a two-step transaction—a *pro forma* assignment ("Step One") followed by a substantial transfer of control ("Step Two") in connection with a proposed merger ("Merger Transaction") of certain broadcast radio subsidiaries of The Walt Disney Company ("TWDC") and Citadel Broadcasting Corporation. The Federal Communications Commission ("FCC") consented to the Assignment on April 18, 2006.

On October 18, 2006, ABC Detroit, Radio License's predecessor, notified the FCC that Step One of the Assignment was completed on September 28, 2006 and that Radio License is now the licensee of E861076.<sup>1</sup> Step Two of the Assignment was not completed at that time because other applications ("Other Applications") related to the Merger Transactions were pending before the FCC, *see, e.g.*, BTC-20060228ABG. On March 22, 2007, the FCC's Media Bureau granted its consent to the Other Applications. *See* In the Matter of Citadel Broadcasting Company, Memorandum Opinion and Order and Notice of Apparent Liability, FCC 07-41 (rel. Apr. 2, 2007).

<sup>1</sup> The FCC's IBFS database indicates that the Assignment was consummated on September 28, 2006. However, only Step One of the Assignment has been consummated.

The FCC previously granted an extension of time, until February 12, 2007, to consummate the Assignment because the Other Applications were pending before the FCC. On February 7, 2007, because the Other Applications were still pending before the FCC, Radio License filed a further request to extend the time to consummate the Assignment for an additional sixty days, until April 13, 2007. This request, a copy of which is attached hereto, remains pending before the FCC. Because the parties have not yet consummated the Merger Transactions and, out of an abundance of caution, an extension of time to consummate the Step Two of the Assignment is necessary. Accordingly, Radio License respectfully requests a further sixty-day extension of time to consummate Step Two of the Assignment.
