On July 17, 2002, the Everest Connections Corporation, a Delaware corporation, filed a certificate of conversion to change its legal form to that of a limited liability company, Everest Connections, LLC, pursuant to Delaware law. This filing constitutes notice of the pro forma assignment of the Receive Only Earth Station Registration from one entity to its successor, which have different Taxpayer Identification Numbers (TINs). However, in every material respect, the change in the legal entity is truly a pro forma change under Delaware law. More particularly, Paragraph (f) of Section 266 of Subchapter IX of Title 8 of the Delaware Code provides, in part, that '...the converting corporation shall not be required to wind up its affairs or pay its liabilities and distribute its assets, and the conversion shall not constitute a dissolution of such corporation and shall constitute a continuation of the existence of the converting corporation in the form of the applicable other entity of this State.'
