The facility covered by this application is used in connection with news-gathering activities at a television station licensed to NBC License Company (LicenseCo), which is under common ownership and control with the licensee of the subject satellite earth station, Birmingham Broadcasting (WVTM-TV), LLC (WVTM LLC). The FCC has consented to the pro forma assignment of the television station license from LicenseCo to its wholly owned subsidiary, NBC WVTM License Company. See FCC File No. BALTC-20060307BUA. The purpose of the instant application is to obtain consent to the pro forma assignment of the satellite earth station license from WVTM LLC to NBC WVTM License Company so that the broadcast station and satellite earth station licenses will be held by the same licensee entity. Because there is no change in the ultimate ownership and control of the subject facility, the application is pro forma in nature.
