Re: Assignment of License - Fixed Satellite Earth Station at Westlake Village, CA (File No. SES-ASG-20070808-01056; Call Sign E070034)

Dear Ms. Dortch:

This letter is filed on behalf of Westlake Wellbeing Properties, LLC (“Westlake WP”), the assignee in the above-referenced assignment application, to report consummation of the assignment authorized on October 29, 2007. *See* FCC Public Notice, Report No. SES-00977, released October 31, 2007. Westlake WP seeks *nunc pro tunc* acceptance of this consummation notice as of November 2007.

Due to an oversight by the parties, no official consummation notice was filed with the FCC to report the November 1, 2007 assignment of this Earth station license from Production & Satellite Services, Inc. (“PSSI”) to Westlake WP. The Commission’s Rules provide that assignments approved by the FCC must be consummated within sixty days, unless an extension is requested, and that notification of consummation must be filed within thirty days thereafter. *See* 47 C.F.R. § 25.119(f). The first of these requirements was met on November 1, 2007, but as noted above, the second requirement was overlooked.

Westlake WP respectfully requests that the Commission accept this letter *nunc pro tunc* reporting consummation of the Earth station license’s assignment from PSSI to Westlake WP, effective November 1, 2007. To the extent necessary, a waiver of Section 25.119(f) of the Commission’s rules is requested. Grant of such a waiver is in the public interest. The assignment of the Earth station to Westlake WP was effected in accordance with the FCC’s

rules, and ownership of Westlake WP remains unchanged since that time. No purpose would be served by requiring the parties to file a duplicate application to seek FCC ratification of this already-completed transaction.
