
Dear Ms. Dortch:

On November 12, 2007, Lincoln Financial Media Company ("LFMC") and Raycom Holdings, LLC ("Raycom Holdings"), a subsidiary of Raycom Media, Inc. ("Raycom"), joined in an FCC Form 312 application for consent to the assignment of the FCC license of transmit-receive earth station E900427 from LFMC to Raycom Holdings (SES-ASG-20071114-01583) (the "Application").


The Assignee's portion of the Application is hereby amended to reflect that the Assignee will be Raycom Sports, LLC ("Raycom Sports") (FRN 0017163106), another subsidiary of Raycom, rather than Raycom's subsidiary Raycom Holdings. The amendment is wholly *pro forma* because Raycom Sports and Raycom Holdings, which share virtually the same officers, are sister subsidiaries of Raycom. Attached is a revised Exhibit E (Ownership Statement) identifying the officers of Raycom Sports (as well as the officers and directors of its sole member and parent Raycom).

\* The issued and outstanding shares of common voting stock of Raycom, the parent of Assignee, are held by qualifying employees under the 1997 Restricted Stock Plan. No one (other than Raycom President Paul H. McTear, Jr.) holds or votes 5% or more of the voting stock. From time to time, additional shares may be issued to qualifying employees. The Employee's Retirement System of Alabama and the Teachers' Retirement System of Alabama (each an instrumentality of the State) hold Raycom's outstanding nonvoting preferred stock (Series D) and common stock warrants.

\*\* Percentage is not calculated for entities and individuals that are listed as having an attributable interest. It is noted that there are not any other parties with an attributable interest in the Assignee under the FCC's equity debt plus (EDP) attribution standard.
