

Broadcast Biscuit, Inc. ("BBI"), by its counsel, hereby re-files its notification to the Commission that the assignment of the license for temporary-fixed transmit-only satellite earth station E040206 from BBI to Spot Media Transfer, Inc. authorized under File No. SES-ASG-20091204-01563 was completed as of February 4, 2010. BBI originally filed this notification by letter dated March 29, 2010, filed by overnight courier and received by the Commission on March 30, 2010 (a copy of the original letter filing and proof of its delivery is attached); however, since BBI did not received the requested date-stamped copy back from the Commission, and the consummation is not reflected in IBFS, and a subsequent follow up inquiry on May 28, 2010 by e-mail (copy attached) to the Commission also has gone unanswered, BBI is re-filing the closing notification out of an abundance of caution.


