This application requests consent to an internal reorganization of the licensee of earth stations E050191, E000661 and E070225 from a Louisiana corporation into a Louisiana limited liability company. Under Louisiana law, the change in organizational form is regarded as conversion of the form of the entity and not a termination of the entity. The converted entity continues its existence and the process of conversion does not alter the ownership interests of the equity holders of the converted entity. As such, the conversion from a corporation to a limited liability company represents a pro forma assignment of the license from KTBS, Inc. to KTBS, LLC without change to the ultimate ownership or control of the licenses.
