Parties to the Application

Following the filing of Application No. SES-ASG-20120802-00714, which requested consent to the assignment of an earth station license (E990392) from Newport Television License LLC to Cox Radio, Inc., a subsidiary of Cox Media Group, LLC ("CMG"), CMG determined that, for tax reasons, the license should be assigned from Newport to a newly-created "exchange accommodation titleholder" entity (an "EAT") before it is assigned to Cox Radio, Inc. The parties recently filed an application with the Media Bureau (File No. BALCDT-20120907AEB) regarding the assignment of the main television station license involved in this transaction.

The two steps that will be involved in the transaction under the revised approach are:

Step 1: Assignment of License from Newport Television License LLC to Cox Television Jacksonville, LLC (the EAT)

Step 2: Assignment of License from Cox Television Jacksonville, LLC to Cox Radio, Inc.

We expect that consummation of the two steps in the transaction would take over the course of a number of weeks or even several months. The parties will file at a later date an application requesting consent to the assignment described in Step 2.

Because there is a potential scenario in which the E990392 license would be assigned directly from Newport Television License LLC to Cox Radio, Inc., the parties have not withdrawn Application No. SES-ASG-20120802-00714.

The proposed assignee of WAWS(TV), Facility ID No. 11909, Jacksonville, Florida (the "Station") and its associated earth station E990392, is Cox Television Jacksonville, LLC ("Cox Jacksonville EAT"). The members of Cox Jacksonville EAT will be TVPEAT, Inc. ("TVPX") and Cox Radio, Inc. ("CRI").

Ownership Information for TVPX

TVPX holds 100% of the equity of Cox Jacksonville EAT and will be the Managing Member. TVPX is a wholly-owned subsidiary of TVPX 1031 Exchange Co.

Ownership Information for CRI

CRI will be the FCC Managing Member of Cox Jacksonville EAT. Although CRI is, for tax purposes, required to be a non-equity member, the governing documents for Cox Jacksonville EAT will make clear that CRI will have exclusive control of the Station.

The sole stockholder of CRI is Cox Media Group, LLC. The sole member of Cox Media Group, LLC is Cox Enterprises, Inc.
