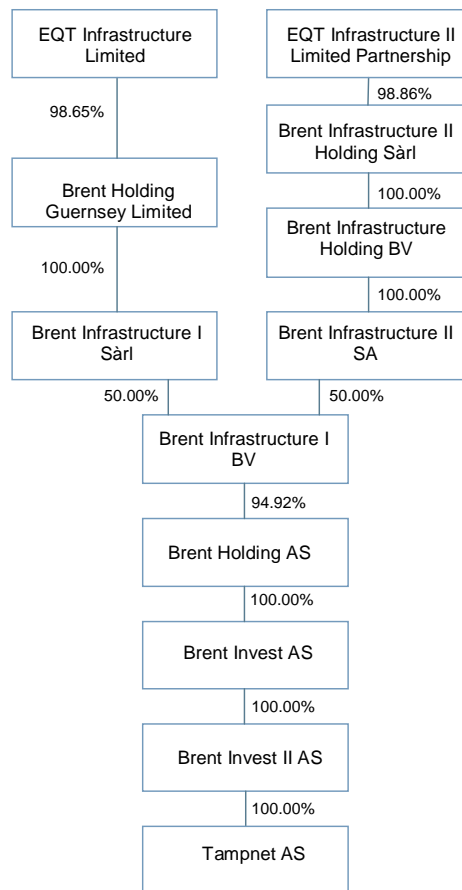


Exhibit E: Response to Question A20

By this application, AirTap Communications, LLC (“AirTap”) and Tampnet Inc. (“Tampnet”) seek Commission consent to the assignment of a Very Small Aperture Terminal (“VSAT”) authorization with Call Sign E100138, which operates on a non-common carrier basis, from AirTap to Tampnet.¹

Pursuant to Question A20 in FCC Form 312, the diagram below sets forth the ownership and control structure of Tampnet. The percentages listed below are the percentages of both the voting and equity stock held in the respective entities.



¹ Contemporaneously with this application, AirTap and Tampnet are also filing with the Commission’s Wireless Bureau an FCC Form 603 seeking Commission consent to the assignment of thirty-seven Microwave Industrial/Business Pool licenses and one 3650-3700 MHz license, all of which operate on a non-common carrier basis, from AirTap to Tampnet Inc. No investor holds a 10% or greater direct interest in EQT Infrastructure I or EQT Infrastructure II Limited Partnership. No other investor holds a 10% or greater direct or indirect voting or equity interest in Tampnet, the proposed licensee.

The transaction presents no foreign ownership issues under Section 310(b) of the Communications Act of 1934, as amended, because all of the FCC licenses to be assigned to Tampnet, including the VSAT license, are licensed on a non-common carrier basis.
