
EXHIBIT E STATEMENT OF NATURE AND EXTENT OF CONTROL

This is one of four notices being filed in connection with the closing of a transaction wherein the applicant licensee, a wholly owned subsidiary of Quincy Newspapers, Inc. ("QNI"), acquired, among other assets, certain International Bureau licenses. Essentially identical exhibits are being filed with each of the four notices.
