The assignee is not authorized to construct nor operate said station(s) unless and until notification of consummation in letter form has been forwarded to the Commission.



Description of Transaction

This filing is to notify the FCC of the *pro forma* assignment of the receive-only earth station authorization (the "Authorization") that is the subject of this application from CBS Communications Services Inc. to CBS Radio Inc. of Maryland as part of an internal corporate restructuring. Both the assignor and the assignee are subsidiaries of CBS Corporation. The *pro forma* assignment was consummated on September 30, 2016.

As demonstrated in the charts below, both before and after the consummation of the proposed transaction, CBS Corporation will continue to control the Authorization.
