DESCRIPTION OF TRANSACTION AND PUBLIC INTEREST STATEMENT (Response to Questions 43 & A21)

Pursuant to 47 C.F.R. § 25.119, EchoStar Broadcasting Corporation ("EBC"), an indirect subsidiary of EchoStar Corporation ("EchoStar"), DISH Network Corporation ("DISH"), and EchoStar Broadcasting Holding Corporation ("EBHC"), a future indirect subsidiary of DISH (collectively, "Applicants"), request Commission consent to a *pro forma* assignment and transfer of control over the earth station licenses specified in Attachment B (the "Earth Station Licenses") and in the accompanying Forms 312, Schedule A (Question A8), from EBC to DISH. Both DISH and EchoStar are controlled by Mr. Charles W. Ergen, who holds a controlling, majority voting interest in both companies.

I. Description of the Transaction and Public Interest Benefits

On January 31, 2017, DISH and EchoStar entered into a Share Exchange Agreement ("Agreement"). Under the Agreement, EchoStar will transfer certain businesses and assets to DISH in exchange for all of the outstanding shares of Hughes Retail Group tracking stock owned by DISH. These businesses and assets include the Earth Station Licenses currently held by EBC.²

¹ All of these earth station licenses authorize non-common carrier services, and thus their *pro forma* transfer requires prior Commission approval under 47 C.F.R. § 25.119(i). Although one of these licenses (*i.e.*, Call Sign E950252) is classified as "common carrier," the Special Conditions of the license state that "[a]ll operations shall be on a non-common carrier basis." *See* Radio Station Authorization, Call Sign, IBFS File No. SES-RWL-20050609-00719 (granted June 21, 2005). In an abundance of caution, the Applicants are including this earth station license, along with all other non-common carrier licenses, in this application for *pro forma* transfer.

² The applicants have filed this application as an assignment to make it clear that the licensee entity is changing, even though the ultimate disposition of the licenses from EC to DISH is a *pro forma* transfer of control.

The transaction will take place in two, near-simultaneous, stages. In the first stage, EchoStar will undertake a series of internal restructuring steps to create certain new, wholly owned and indirect subsidiaries, including EBHC. EchoStar will transfer certain assets of EBC to EBHC, including the Earth Station Licenses, and EBC will cease to exist.

In the second stage of the transaction DISH will exchange its Hughes Retail Group tracking stock for all of the shares of EBHC. As a result, following the transaction's closing, DISH will indirectly own and control, among other things, the Earth Station Licenses formerly held by EBC.³ The ownership structure is set forth in Attachment A (Ownership Diagram) to this application. Ultimate control over the Earth Station Licenses will continue to be exercised by Mr. Ergen through his ongoing control of DISH.⁴

This *pro forma* transaction will serve the public interest by creating a more efficient structure to facilitate investment in DISH and its affiliated companies.

II. Authorizations to be Transferred

The Applicants request consent for transfer of the Earth Station Licenses listed in Attachment B. The Applicants further request that grant of this application include Commission consent to the *pro forma* transfer to EBHC of all other earth station authorizations currently held by, or issued on or after this filing date to, EBC, including (i) existing special temporary

Among them, these companies hold a private wireless license, Local Multipoint Distribution Service licenses, and various equipment authorizations, all of which will transfer to DISH. The applicants are separately seeking consent for, or will notify the Commission of, as appropriate under FCC rules, these *pro forma* transfers of control.


authorizations ("STAs");⁵ and (ii) STAs and licenses granted pursuant to a pending application at the time of the transaction's close.


III. Certification

The Applicants certify that the proposed transfer is *pro forma* and will not result in a substantial change in control over the Earth Station Licenses. The FCC has already passed on the qualifications of DISH to control FCC licenses. Moreover, Commission approval of the proposed transfer does not require a waiver or declaratory ruling regarding any applicable FCC rule. Thus, under 47 C.F.R. § 25.119(i), Commission approval will be deemed granted one business day after filing.
