

Ownership Exhibit

The proposed *pro forma* assignment of license is being filed in connection with a three-part company reorganization, whereby (1) Sinclair Communications, LLC (“SCLCC”) parent of WHP Licensee, LLC (“WHP”) created a new wholly-owned subsidiary, Harrisburg Licensee, LLC (“Harrisburg”), (2) WHP merged with and into SCLLC, with SCLLC as the surviving company, and (3) following the merger, SCLLC contributed WHP’s FCC authorizations to Harrisburg.

In sum, the licensee subsidiary will change from WHP Licensee, LLC to Harrisburg, Licensee, LLC, while SCLLC will retain its 100% ownership interest in the licensee, as depicted in the chart below. The proposed transaction does not involve any changes to the ultimate ownership of the Licensee.
