This information in this exhibit is being provided pursuant to Section 310(d) of the Communications Act, as amended, and Section 25.119 of the Commission's rules, 47 C.F.R. § 25.119, in support of the instant application for Commission consent to the assignment of the license to operate a transmit/receive earth station in Doral, Florida, call sign E120059 (the "Station"), from Licensee/Assignor Mapale LLC ("Assignor" or "Mapale") to Assignee Caracol America Productions LLC ("Assignee" or "CAP").

This exhibit addresses Questions 43 & A20 (Description of the Transaction and Assignee Ownership) and Question A21 (Public Interest Statement)

Response to Question 43 (Description of the Transaction) and A20 (Assignee Ownership)

Mapale owns and operates the Station and, prior to March 15, 2018, owned and operated television station WGEN-TV, which used the Station in connection with programming aired on WGEN-TV. Assignee and Assignor are affiliated companies, with at least 25% of ownership in common. Given the common ownership that exists between Assignee and Assignor, there is no written agreement for the assignment of the Station's facilities from Assignor to Assignee.

Assignee is engaged in the business of providing video programming to one or more clients in the United States and plans to use the Station in connection with the programming services it offers. In this regard, the use of the Station is similar to its use during the Assignor's ownership.

Assignee is a wholly-owned subsidiary of Caracol TV America Corp., which is a Delaware corporation that has a 25% ownership interest in Assignor Mapale LLC. Caracol TV America Corp., in turn, is a wholly-owned subsidiary of Caracol Televisiòn S.A., which is a publicly-traded Colombian corporation. Invernac & Cia. S.A.S., a Colombian Simplified Joint Stock Company, and Valorem S.A., a Colombian corporation, both have 10% or more ownership interest in the Assignee CAP. Both Invernac & Cia. S.A.S. and Valorem S.A. also have at least a 5% ownership interest in the Assignor Mapale LLC. Information about Caracol Televisiòn S.A., Invernac & Cia. S.A.S., and Valorem S.A. is available in the Commission's records in LMS File Nos. 0000043576, 0000043572, 0000043571.

Response to Question A21: Public Interest

Assignment of Mapale's license for the Station to CAP will serve the public interest. The Assignee is an established company that provides video programming services and facilities in the Miami, Florida, area, and CAP will use the Station in furtherance of its commercial video programming services activities in Florida and throughout the United States. This use of the Station is substantially similar to the use of the Station made by the Assignor and, as a result, we respectfully submit that grant of this earth station license assignment is in the public interest.
