DESCRIPTION OF TRANSACTION

The instant Form 312 application serves as notification of the assignment of receive-only earth station registrations E050186, E181066, E180979, and E180980 from WSIL-TV, Inc. to Quincy Media, Inc.¹ WSIL-TV, Inc. was until recently also the licensee of television stations WSIL-TV, Harrisburg, Illinois and KPOB-TV, Poplar Bluff, Missouri. A Media Bureau application on FCC Form 314 with respect to WSIL-TV and KPOB-TV has been filed and granted, and the transaction has consummated as of January 15, 2019.
