Re: Section 1.65 Notification of Change to the Ownership and Control of UltiSat, Inc.

Dear Ms. Dortch:

UltiSat, Inc. ("UltiSat"), by its attorneys, submits this letter pursuant to Section 1.65 of the rules of the Federal Communications Commission ("FCC").

On April 23, 2020, Speedcast International Limited—the ultimate parent of UltiSat—and thirty-two (32) of its subsidiaries, not including UltiSat, each commenced a voluntary case under chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Southern District of Texas (Case No. 20-32243 (MI)) (the "Chapter 11 Cases"). On May 4, 2020, in connection with the Chapter 11 Cases, Speedcast Americas, Inc. and its wholly-owned subsidiaries holding FCC licenses or authorizations, including UltiSat, filed for *pro forma* assignment and transfer of control of those licenses to their respective debtors, as debtors-in-possession. While UltiSat is not a debtor in the Chapter 11 Cases, or in any other chapter 11 proceeding, the *pro forma* transfer of control of licenses reflects the transfer of control of UltiSat from Speedcast Americas, Inc. to Speedcast Americas, Inc., as debtor-in-possession.
