Assignment Will Serve the Public Interest

THE EARTH STATION WHICH IS THE SUBJECT OF THIS LICENSE ASSIGNMENT APPLICATION, E060203, AND THE NON-COMMERICAL RADIO BROADCAST STATION WITH WHICH IT WAS ASSOCIATED, WWNO (FACILITY ID NUMBER 38607), WERE TRANSFERRED FROM ONE LOUISIANA UNIVERSITY TO ANOTHER PURSUANT TO ACT 419 ADOPTED AS PART OF THE 2011 REGULAR SESSION OF THE LOUISIANA LEGISLATURE.

PRIOR TO THE ADOPTION OF ACT 419, LOUISIANA STATE UNIVERSITY AND AGRICULTURAL AND MECHANICAL COLLEGE'S NEW ORLEANS CAMPUS, THE UNIVERSITY OF NEW ORLEANS, WAS UNDER THE GOVERNANCE OF THE BOARD OF SUPERVISORS OF LOUISIANA STATE UNIVERSITY AND AGRICULTURAL AND MECHANICAL COLLEGE. ACT 419 PROVIDED FOR ASSIGNMENT OF THE UNIVERSITY OF NEW ORLEANS TO A SEPARATE STATE COLLEGE SYSTEM KNOWN AS THE UNIVERSITY OF LOUISIANA SYSTEM ("UL SYSTEM"), WHICH IS CONTROLLED BY A DIFFERENT BOARD OF SUPERVISORS.

ACT 419 ALSO REQUIRED A TRANSFER OF UNIVERSITY ASSETS IN CONJUNCTION WITH THE CHANGE IN GOVERNANCE, TO TAKE PLACE AFTER THE ACCREDITATION OF THE UNIVERSITY OF NEW ORLEANS BY THE SOUTHERN ASSOCIATION OF COLLEGES AND SCHOOLS, COMMISSION ON COLLEGES (SACS). THAT ACCREDITATION WAS SUBSEQUENTLY GRANTED, AND IN ACCORDANCE WITH ACT 419, THE ASSETS OF NONCOMMERCIAL RADIO BROADCAST STATION WWNO, INCLUDING ITS FCC LICENSE AND OTHER AUTHORIZATIONS, WERE TRANSFERRED TO THE UNIVERSITY OF NEW ORLEANS, CONTROLLED BY THE BOARD OF SUPERVISORS FOR THE UL SYSTEM. (SEE FCC FILE NUMBER BALED-20111223AAE.) HOWEVER, THROUGH INADVERTENT OVERSIGHT, THE FCC AUTHORIZATION FOR EARTH STATION E060203 STILL REMAINS TO BE ASSIGNED. THIS APPLICATION SEEKS FCC AUTHORITY TO COMPLETE THAT ACTION AS AUTHORIZED BY ACT 419.
