

PARTIES TO THE APPLICATION

As explained in Exhibit F, this application is one of several applications pursuant to which the applicant seeks consent to a pro forma assignment or transfer of control of licenses in connection with a company reorganization. These transactions will effect no change in the ultimate ownership or control of the licensee entity. Entercom Communication Corp. (“Entercom”) will remain the ultimate parent both before and after the restructuring.

Upon consummation of the proposed transaction, the ownership of Entercom License, LLC will be as follows:
