DESCRIPTION OF TRANSACTION AND PUBLIC INTEREST STATEMENT

WorldVu Satellites Limited ("OneWeb") respectfully requests Commission consent to the *pro forma* assignment and transfer of control of OneWeb in connection with OneWeb's recent Chapter 11 bankruptcy filing.¹ OneWeb submits this application as one in a series of *pro forma* filings being submitted contemporaneously to the Commission.²

Description of Transaction

On March 27, 2020, OneWeb and certain of its affiliates filed petitions for relief under Chapter 11 of Title 11 of the United States Code (the "Bankruptcy Code") in the United States Bankruptcy Court for the Southern District of New York (the "Bankruptcy Court"). On April 1, 2020, the Bankruptcy Court entered an order directing the joint administration for procedural purposes of all of the OneWeb related Chapter 11 cases.³

Currently, OneWeb continues to operate its network, including its earth and space stations, as a debtor in possession pursuant to the Bankruptcy Code. OneWeb's Chapter 11 filing constitutes a *pro forma* transfer of control because OneWeb's operations are now subject to the ongoing supervision of the Bankruptcy Court. Subsequent to the Chapter 11 bankruptcy filing, the earth station licenses, market access grant, and experimental licenses granted to OneWeb are held by OneWeb DIP.⁴ Other than the fact that OneWeb is now operating as a debtor in possession, there is no change to the ownership or control of OneWeb as a result of the Chapter 11 bankruptcy filing.

Grant of the Applications Would Serve the Public Interest

OneWeb has made tremendous progress to lay the foundation for delivering innovative, satellitebased connectivity services from its low-earth orbit, non-geostationary satellite orbit ("NGSO") constellation. The Chapter 11 restructuring process will allow OneWeb to significantly improve its financial position through a sale or reorganization of the business focused on maximizing the unique value proposition of its NGSO-based network. OneWeb does not expect any changes to

its day-to-day satellite operations or disruptions to the safe and reliable operation of its earth and space station assets as a result of the Chapter 11 bankruptcy filing. Prior to emerging from Chapter 11, OneWeb will obtain all necessary regulatory approvals from the Commission. Therefore, grant of the instant application would serve the public interest by allowing OneWeb to retain its Commission licenses and authorizations as it undergoes the restructuring process described herein and would be consistent with Commission treatment of previous satellite-related Chapter 11 bankruptcy proceedings.⁵

Conclusion

For the foregoing reasons, OneWeb respectfully requests Commission consent to the *pro forma* assignment and transfer of control of OneWeb's Commission licenses and authorizations.
